# NOTICE OF UPCOMING HERMOSA AVENUE CONSTRUCTION

September 12, 2018

#### Subject: Hermosa Avenue Pavement Resurfacing Project (CIP 16-174)

Dear Occupant/Property Owner:

This notice is to let you know that the City of Hermosa Beach will begin construction the week of Sept. 17 on Hermosa Avenue between 10<sup>th</sup> Street (south) and 26<sup>th</sup> Street (north), highlighted on the map to the right. The project will include the following improvements:

- Remove and re-construct curb ramps to meet current Americans with Disability Act (ADA) requirements
- Remove and replace selected portions of curbs and gutters as well as sidewalk
- Grind existing asphalt street surface and resurface with new asphalt
- Install new crosswalks at 10<sup>th</sup>, 11<sup>th</sup>, 13<sup>th</sup> and 14<sup>th</sup> streets; as well as new bus shelters, benches and trash receptacles along the route.
- Upgrade traffic signals at 11<sup>th</sup>, 13<sup>th</sup> and 14<sup>th</sup> streets.

### **Construction Schedule Seeks to Minimize Inconvenience**

To minimize inconveniences, the construction work will be split into several phases with three to four blocks under construction at a time. Every effort will be made to keep one lane of travel open in each direction and to limit parking restrictions to the minimal area needed to safely complete the work. Most construction will take place between 8 a.m. and 6 p.m. Monday through Friday. However, some crosswalk installations may occur during nighttime hours to minimize traffic delays.

Construction on the Hermosa Avenue project is expected to take approximately 80 working days spread over five months and will avoid weekends, holidays, and the peak holiday shopping season. The project is scheduled to be completed in February, pending weather delays and other unforeseen conditions.
