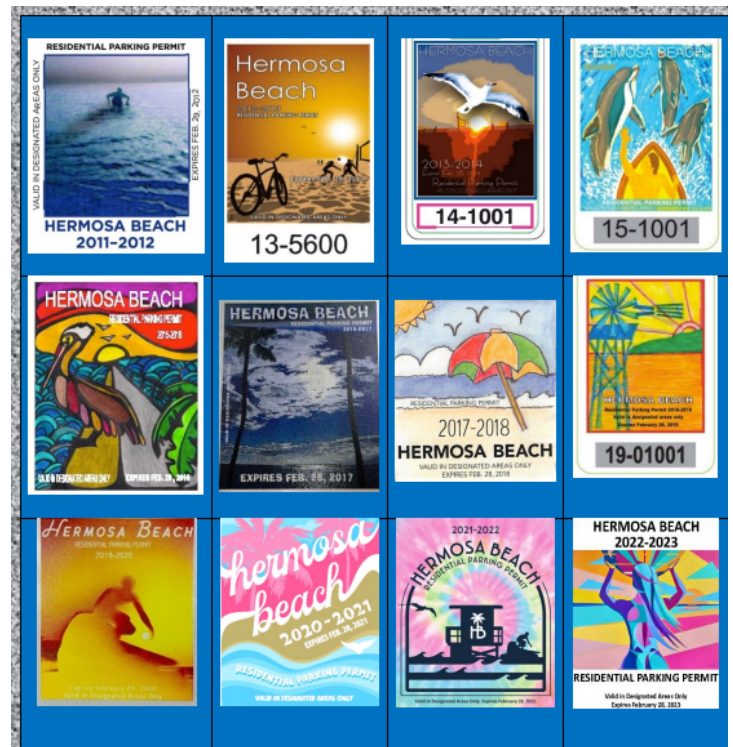

Eligibility

The contest is open to all current Hermosa Beach Residents.
(Limit 1 entry per resident)

Design

- Be creative! While you may use themes selected in previous years, we encourage you to use novel themes or add your own unique elements to previous themes. You may resubmit artwork not chosen in previous years.
- Previous designs have included: windmill, surf statue, surfing, lifeguard towers, paddle boarding, bicycles, beach volleyball, seagulls, dolphins, pelicans, sunset, palm trees, and beach umbrellas.
- Artwork must be designed by current residents.

Artwork Submission Requirements

- Artwork must be submitted for both the square decal and the hanging tag within the specifications shown in the contest template.
- The art concept must contain all of the following information:
 - Hermosa Beach
 - 2023-2024
 - Expires February 28, 2024
 - Residential Parking Permit
 - Valid in Designated Areas Only

(The design must include space for the permit number box as shown in the contest template)

Art Selection and Award

The winner will be chosen by the City Manager. If you live in the restricted area, you will be awarded one free permit. If you do not live in the restricted area, you will be awarded the monetary value of one permit.

Use Rights

- Each artist warrants that he or she alone created the submitted work of art and that it is an original work of art and not a copy or derivative of any other copyrighted or published work of art.
- All entries will not be returned.
- If the content of your entry is claimed to constitute an infringement of any proprietary or intellectual proprietary rights of any third party, you shall, at your sole expense, defend or settle against such claims.
- By entering this Contest, you are granting the City of Hermosa Beach a non-exclusive perpetual license to reproduce images of your artwork on the City of Hermosa Beach website, on City of Hermosa Beach social media channels, on residential parking permits, in promotional newsletters, and in the marketing of the art competition to the general public.
- No resale of or exchange of images will occur by the City of Hermosa Beach. All images are the property of the artist and the artist retains the sole copyright and all applicable rights to said images.

Disqualification

- Submissions will be ineligible if they contain the following:
- A breach of intellectual property—any work or content that is not the artist's
- Trademarks, brands or business names, logos or copyrighted images
- Anything that is harmful to a third party or that promotes: violence or illegal activity; obscene, sexually suggestive, vulgar, or profane images; a political candidate, political party, initiative, referendum, ballot measure; or implies an endorsement by the City of Hermosa Beach for any person, product, or service.

Other Acknowledgements

- All costs of proposal preparation shall be borne by the contestant.
- The City reserves the right to extend the submission deadline if, in the City's sole judgment, an extension would be in the City's best interests.
- The City reserves the right to reject all designs that it receives and to refrain from selecting new residential permit artwork through this process.

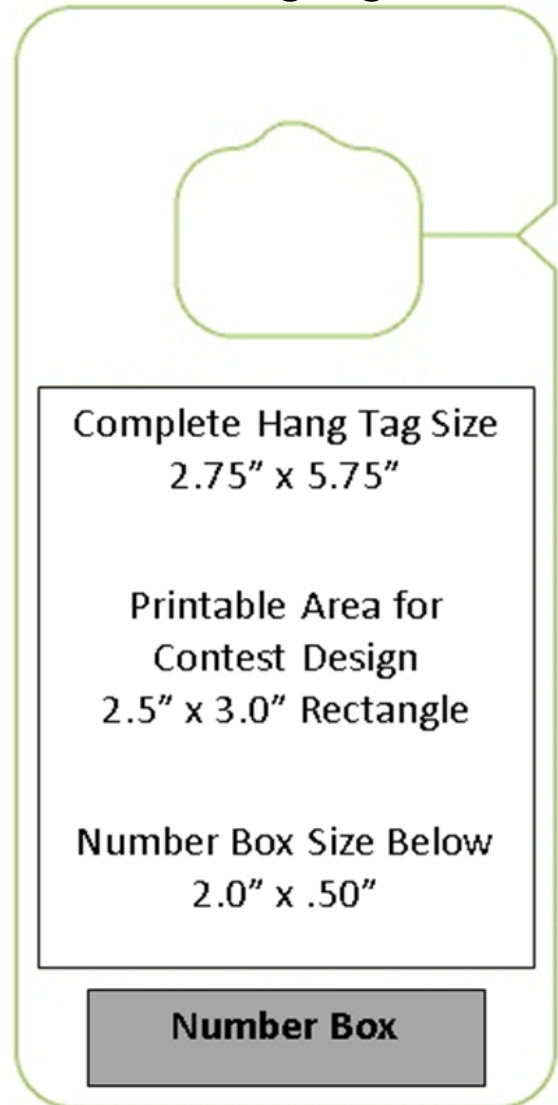
Round Decal Design
