The following is an explanation of how most plans are routed through the County of Los Angeles Fire Prevention Division. It is not all inclusive so any unique question that may arise can be vetted through the Local Engineering Section or the Regional Unit at the numbers listed below.

Local Engineering Section

Fire Prevention Headquarters - Commerce 5823 Rickenbacker Road Commerce, CA 90040 (323) 890-4125

Responsible for all plan checks for any New Construction. Additions, Relocated Structures and any change of occupancy will also be reviewed at this location.

Initial Plan Submittal is now through Epic LA.

Sprinkler and Fire Alarm Unit

The Sprinkler Unit is Responsible for all new Sprinkler System plan checks. They will also review all plans for additions, alterations or modifications to any existing system involving more than 20 sprinkler heads.

The Fire Alarm Unit is responsible for all Fire Alarm System plan checks.

Initial Plan Submittal is now through Epic LA.

The LDU will review all plans for Tract maps, Parcel Maps, Planned Unit Developments, Conditional Use Permits, Design Overlay Reviews, Environmental Impact Reviews, Road Vacations, Zone Changes, water plan reviews and gate design review for LDU projects.

- Fire Sprinkler System modifications involving 20 sprinkler heads or less.
- Removal of Underground flammable or combustible liquid storage tanks.
- Field Inspections.
- Special Events. (To be handled by the Carson Office)

The Schools and Institutions Unit is responsible for building and alarm plans for R-2 and R-6 occupancies. This includes new construction, additions and alterations to existing buildings that have a change in occupancy classification.
