Specifically:

- Macpherson Oil: Michael DiVirgilio and I negotiated an end to the \$750,000,000 lawsuit against our City that removed the threat of bankruptcy - or worse - from our future.
- Infrastructure: As Chairman of the Upper Pier Avenue project we re-beautified Pier Avenue and made our street the new jewel of the South Bay.
- Public Safety: As Mayor I led the effort on the Fourth of July to bring 50 Sheriffs Deputies to Hermosa to manage the crowds. We tripled fines, enforced codes, and used social media tools. For the first time in years Hermosa kept its independence.
- Environment: Led the project that installed an innovative filtration system to keep stormwater from polluting our bay. The solution won an EPA award and Heal the Bay recently gave our beach an "A" rating.
- Budget: I will continue to make fiscal decisions to keep our City sustainable for the long-term and focus our resources on our core needs.
