| Feb 10 (Tu)                  | - Last day for City Clerk to mail sample ballots and polling place notices  |
| Feb 17 (Tu)                  | - Last day to register to vote (since Mon., Feb. 16 is a holiday)   |
| Feb 19 (Th)                  | - Last day for committees to file 2nd pre-election Campaign Statements<br>(reporting period Jan. 18 – Feb. 14, 2015)<br>- City Clerk to post Notice regarding pre-election Vote-By-Mail Canvass<br>- City Clerk to post Notice of Polling Places and Precinct Board Members<br>- City Clerk to publish Notice of Election<br>- City Clerk to publish Notice of Central Counting Place<br>- City Clerk to publish Notice of Polling Places |
| Feb 25 – Mar 3 (W-Tu)        | - Emergency/Late Vote-By-Mail (VBM) voting period   |
| Mar 2 (M)                    | - City Clerk to post Notice regarding post-election VBM Canvass   |
| Mar 3 (Tu) [7 a.m. - 8 p.m.] | - Election Day  |
| Mar 6 (F)                    | - Last day to receive VBM ballots postmarked no later than Mar. 3   |
| Mar 27 (F)                   | - City Clerk to complete Canvass of Ballots and Conduct Manual Tally  |
| Apr 1 (W)                    | - City Clerk to submit report on measures to Secretary of State   |
