



CONSTRUCTION RULES

The City of Hermosa Beach does have permissible hours of construction. Per the Hermosa Beach Municipal Code Section 8.24.050, all construction shall be conducted between the following hours:

CONSTRUCTION HOURS

Monday – Friday (Weekdays): 8:00 a.m. – 6:00 p.m.

Saturdays: 9:00 a.m. – 5:00 p.m.

Construction activity is prohibited at all other hours, on Sundays, and National Holidays.*

(HOMEOWNERS EXEMPTION):

10:00 a.m. – 2:00 p.m. Sundays/National Holidays*

National Holidays recognized by the City:

New Year's Day; Martin Luther King, Jr. Day; Presidents' Day; Memorial Day; Independence Day; Labor Day; Veterans' Day; Thanksgiving; and Christmas.

The City does enforce these regulations and they must be posted on the construction site with a construction sign issued by the Community Development Department. This sign must be placed in a location that is visible from the public right-of-way. Failure of the property owner and/or contractor to post and comply with these construction hours may result in issuance of a Stop Work Order and/ the issuance of an Administrative Citations.

Violations of the allowable hours of operation should be reported to the Code Enforcement Department at **(310) 318-0234** during normal business hours (7:00 a.m. to 6:00 p.m. Monday through Thursday). After-hours and on weekends, violations should be reported to Code Enforcement via the GoHermosa! mobile application. The non-emergency Police Department line can also be used to report suspected violations to an on-duty Police Officer

ADDITIONAL REQUIREMENTS

For purposes of this section, "construction" or "construction activity" shall include site preparation, demolition, grading, excavation, and the erection, improvement, remodeling or repair of structures, including operation of equipment or machinery and the delivery of materials associated with those activities.

PEDESTRIAN PROTECTION

Pedestrian protection is required - All construction sites must be fenced. Chain link fencing with slats or screening incorporated are required per Section 15.04.140 of the Municipal Code. Projects not complying with these provisions are subject to a Stop Work Order.

PARKING/STAGING

Violations of the California Vehicle Code or City parking rules should be directed to the **non-emergency Police dispatch line at (310)524-2750** so that an on-duty Parking Enforcement Officer can be notified to address your concerns. A Staging Permit is required for the staging of construction related vehicles/equipment in the public right-of-way. Violations involving the staging of vehicles related to construction can be reported to **Public Works at (310)318-0214**.

NOISE CONTROL

Section 8.24.040 specifies that the prohibition of the amplification of music or any other sound on private property, through speakers located either (1) outdoors, or (2) in one (1) or more windows or doorways, when such speakers are directed towards, and such music is plainly audible on, an immediately adjacent public right-of-way. Violations of the noise control ordinance should be reported to the Code Enforcement Department at **(310) 318-0234** during normal business hours (7:00 a.m. to 6:00 p.m. Monday through Thursday). After-hours and on weekends, violations should be reported to the non-emergency Police Department line at **(310) 524-2750**.
