Suspect used counterfeit \$50 bill to pay for food.

484PC THEFT Reported 4/27/16 @ 0830 <u>600 BLK 11TH ST</u>

Computer theft scam with a loss of \$279.

470PC FORGERY Reported 4/27/16 @ 1223 **400** BLK HERONDO

Suspect cashed fraudulent check using the victim's banks account info.

Victim believes an unknown suspect(s) entered her unlocked residence, while she was walking her dog, and took her laptop.

Motorcycle license plate stolen from vehicle parked in underground parking structure of apartment complex.

Suspect stole vehicle and threatened a victim when confronted. Suspect left vehicle, fled and began entering vehicles where he stole items. Suspect was contacted walking on foot by officers. Unknown suspect(s) attempted to open two different credit card accounts with two different banks; both were declined.

Suspect uses counterfeit \$100 bill to pay for food order, gets change and leaves before food was bagged for pickup.
