Known suspect kicked the victim's passenger side doors after a minor traffic collision.

Unknown suspect enters secured shared parking garage by possibly prying open door, enters unlocked vehicle and steals items.

Victim left purse at bar and upon return it was gone.

Front license plate stolen from vehicle.

Suspect threw an unknown item (possibly a banana) from a vehicle at the victim's vehicle causing the driver window to crack.

Unknown suspect entered business, used the restroom and stole property from the victims.

Unknown suspect accessed victim's account from ATM to withdrawal money without permission.			
<b>484GPC</b>	<b>THEFT USE ACCESS CARD</b>	<b>Between 06/25/16 @ 1300 - 06/27/16 @ 1051</b>	<b>1500 BLK PACIFIC COAST HY</b>
Unknown suspect used victim's information to withdrawal money from the victim's account.
